

ORDINANCE 1895

AN ORDINANCE AMENDING CHAPTER 69, PARKING REGULATIONS, OF THE MUNICIPAL CODE OF THE CITY OF ANKENY, IOWA, BY AMENDING SECTION 69.10, NO PARKING ON NORTH AND EAST SIDES OF STREETS, TO ALLOW FOR THE ADDITION OF “NO PARKING” ZONES ALONG THE SOUTH SIDE OF:

- 1. NW REINHART DRIVE FROM NW STATE STREET TO A POINT 165 FEET WEST OF THE CENTERLINE OF NW STATE STREET, AND**
 - 2. NW REINHART DRIVE FROM NW ASH DRIVE TO A POINT 130 FEET WEST OF THE CENTERLINE OF NW ASH DRIVE, AND**
 - 3. NW REINHART DRIVE FROM NW ASH DRIVE TO A POINT 130 FEET EAST OF THE CENTERLINE OF NW ASH DRIVE, AND**
 - 4. NW REINHART DRIVE FROM N ANKENY BOULEVARD TO A POINT 185 FEET WEST OF N ANKENY BOULEVARD.**

BE IT ORDAINED, by the City Council of the City of Ankeny, Iowa:

Section 1. That Section 69.10, NO PARKING ON NORTH AND EAST SIDES OF STREETS, of the Municipal Code of the City of Ankeny, Iowa, be and it is hereby amended by adding subsections “2.AB.” and “2.AC.” and “2.AD.” and “2.AE.” as follows:

2. Exceptions. Notwithstanding the provisions of this section, parking is authorized or prohibited along certain streets as hereinafter set forth:

AB. Northwest Reinhart Drive. Parking is prohibited on the south side of Northwest Reinhart Drive from Northwest State Street to a point 165 feet west of the centerline of Northwest State Street;

AC. Northwest Reinhart Drive. Parking is prohibited on the south side of Northwest Reinhart Drive from Northwest Ash Drive to a point 130 feet west of the centerline of Northwest Ash Drive;

AD. Northwest Reinhart Drive. Parking is prohibited on the south side of Northwest Reinhart Drive from Northwest Ash Drive to a point 130 feet east of the centerline of Northwest Ash Drive;

AE. Northwest Reinhart Drive. Parking is prohibited on the south side of Northwest Reinhart Drive from North Ankeny Boulevard to a point 185 feet west of North Ankeny Boulevard.

Section 2. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 3. This ordinance shall be in full force and effect after its passage, approval, and publication as provided by law.
